## Kinsman Road Extension Opens Five Months Early, On Budget Road Work Combines Multiple Infrastructure Projects to Save Taxpayer Funds

Wilsonville Community Development Department staff announced the opening during the week of Jan. 15 of the new Kinsman Road extension, which connects Barber Street to Boeckman Road, that was completed on budget and five months ahead of schedule. In addition to providing another routing

connection for travelers, construction of the roadway incorporated simultaneously other water- and sewerinstallation infrastructure projects that resulted in reduced public disruption and costs.

Originally scheduled for completion in June 2018, the \$8.6 million half-mile-long roadway segment, located between Villebois and the industrial westside of Wilsonville, connects two major arterials that greatly improves the city street-grid and provides increased connectivity for both freight and residential traffic. The new Kinsman Road extension was constructed as a heavy-duty concrete roadway complete with sidewalks and bike lanes that also provides increased public access to the Wilsonville Transit Center, including SMART Central bus and Tri-Met WES commuter rail service.

City engineer Zach Weigel, PE, who oversaw the project, indicates that advance planning and permitting activities, favorable weather and well-coordinated government agencies and contractors contributed to the early completion of the project. City Community Development Director Nancy Kraushaar, PE, said, "The Kinsman Road extension project is a real winwin for the public that provides new travel routing

options, as well as reduced costs for additional major water and sewer projects."

City engineers worked to combine \$5.1 million of other public infrastructure projects with the long-planned road extension in order to *Continued on page 2*

Town Center Plan manager Miranda Bateschell said, "Now we need to hear from Wilsonville residents and business managers! What did we get right? What did we miss? What should change?" These are good questions that I hope you will help answer.

Led by a City Council-appointed volunteer task force, the Wilsonville Town Center Plan seeks to guide development in the

guide development in the 100-acre Town Center area to create a cohesive, unified district that enhances existing assets in the area and sets the stage for new development. City staff and consul-



tants have spent considerable time and effort over the past year to attend community events, interview stakeholders and undertake public surveys in order to build a community-driven vision for a vibrant Town Center.

A special joint City Council-Planning Commission meeting held on Dec. 4 reviewed public comment and findings to-date that showed significant community support for a more walkable, "Main Street district" with denser, taller mixed-use buildings that offer various dining options, including outdoor eating, and a wider array of small-business shopping opportunities. Funding for the project is provided by a Metro Community Planning and Development Grant with matching funds from the City's Urban Renewal Agency. ## Kinsman Road Extension Opens Five Months Early, On Budget **Road Work Combines Multiple Infrastructure Projects to Save Taxpayer Funds**

in order to more efficiently use taxpayer-funds. The Kinsman Road project included the installation of a \$4.0 million segment of a major drinking-water pipeline and a \$1.1 million sanitary sewer pipe. Simultaneous construction of the road, Willamette Water Supply Program (WWSP) water pipeline and City sewer project allowed various local governments to all

save money and minimize disruption to the public. All projects saved money by utilizing one contractor and sharing common costs, such as contractor mobilization, traffic control, permitting, project design, rightof-way acquisition and environmental protections that all three projects would have incurred if performed separately.

The Willamette Water Supply Program, a partnership between the Tualatin Valley Water District (TVWD) and the City of Hillsboro, installed nearly 3,000 feet of 66-inch diameter pipeline that is the first completed section of 30 miles of large-diameter water-supply pipeline from Wilsonville to Hillsboro

and Beaverton. The pipeline is made of half-inch thick steel with welded joints, a cement mortar lining inside the pipe, and a highly durable polyurethane coating on the outside. Future segments of the pipeline are to connect along Boeckman Road to the east and on Kinsman Road to the south of Barber Street.

The City also installed over 3,000 feet of new sewer line in the acquired road right-of-way that is designed to serve the regionally significant Coffee Creek industrial area now under development.

The Coffee Lake wetlands complex adjoins both sides of the Kinsman Road extension. The west side of the new roadway features an extra-wide sidewalk and benches for wildlife and habitat viewing. Fencing along the road and a series of wildlife corridor passages beneath Kinsman Road, including round and box culverts, were constructed to improve safety for both drivers and wildlife. These details maintain wildlife corridors within an urban landscape and mirror the natural resource protection previously achieved with

the Boeckman Road project that also crosses the wetlands.

The project design team was led by OBEC Consulting Engineers, and Emery and Sons **Construction Group** of Salem managed the construction project. The water-supply pipe was manufactured by Northwest Pipe Co., which specializes in large-diameter steel pipelines. A total of 90 local jobs are estimated to have been sustained during the course of the 12-month-long project.

Funding for the combined \$13.7 million road-sewerwater pipeline project came from City transportation and wastewater system development charges, federal/ state funds (U. S. Dept. of Transportation Multimodal Transportation Enhance Program (MTEP) through the Statewide Transportation Improvement Program (STIP) and Surface Transportation Program Urban (STP-U)), and the ratepayers of TVWD and City of Hillsboro.





## Road Project to Provide Key Access to New Coffee Creek Employment Area, Improve Connectivity Improvement of Rural Road to Urban Standards Facilitates High-Wage Job Development, Extends City Street Grid

The City of Wilsonville continues to make progress ▲ on phase 1 of the design of Garden Acres Road an important transportation project supporting development of the new regionally significant Coffee Creek Industrial Area. Added to the region's urban growth boundary in 2002 by Metro, the Coffee Creek area is targeted for over 1,500 mostly high-wage jobs in light manufacturing and assembly, software engineering

and warehousing with an annual payroll exceeding \$55 million.

Located in northwest Wilsonville near the Coffee Creek Correctional Facility, Garden Acres Road is intended to be the primary north-south street serving industrial development. The current roadway is a narrow, dead-end, two-lane county road barely 20 feet

wide. Phase 1 of the road project widens the road to 32 feet, providing two 12-foot travel lanes with an 8-foot buffered bikelane on the west side. On the east side, a landscaping strip is to be installed with an 8-foot bikelane and 5.5-foot-wide sidewalk separated from the traffic lanes.

Overhead power and telecommunications lines are to be relocated underground within a 10-foot public utility easement east of the sidewalk. Two other features of the project are an extension of the city's sanitary sewer line northward to Day Road, and installation of a large diameter 66-inch water line by the Willamette Water Supply Program (WWSP). Phase 2 of the project completes the full road section on the west when property owners express interest to annex into the City and develop with full urban services.

"The size and extent of utility improvements under the roadway create significant coordination challenges," said Eric Mende, the City's Project Manager, "but

we have an excellent team working through the design issues, including the efforts of numerous consultants, staff from Wilsonville and WWSP, and representatives from PGE, NW Natural, and the telecom companies."

To support the project, the City Council recently approved annexation and transfer of road ownership of Garden Acres Road from Washington County to the City - a key step preceding right-of-way and publicutility easement acquisitions; see City Council reports on page 6.

Phase two of the road project connects Garden Acres Road to a new roundabout intersection with Day and Grahams Ferry Roads, thereby furthering Wilsonville's developing street grid that improves connectivity and mobility by offering a variety of routing alternatives.

Property owners on the east side of the road can expect contact from the City's appraiser and right-ofway agent within the next couple months. Property owners on the west side of Garden Acres Road are generally not be affected by the acquisition process.

The City hopes to complete design and acquisitions and be under construction by October, with construction completed by October 2019. ## City Advances Innovative 'Form-Based Code' for Development of Coffee Creek Industrial Area New Building Code Offers Alternative Method for Faster, Streamlined Development Approval

With a favorable Planning Commission recommendation in January, the City's proposed pioneering Coffee Creek Industrial Form-Based Code is expected to be ready for City Council consideration in February. While used traditionally for commercial/ mixed-use construction, Wilsonville is proposing for the first time in the U.S. to use a form-based code exclusively for industrial development.

The City aims to adopt these new development regulations for the Coffee Creek Industrial Area to create a connected, campus-like atmosphere with high-quality design. The Form-based Code provides standards for building design, roadway connections, and site layout, and would apply to Coffee Creek properties at the

Wilsonville is proposing for the first time in the U.S. to use a form-based code exclusively for industrial development. time of annexation and development.

Form-based codes differ from conventional development codes by setting clear, objective standards for the development of the public

realm supported by regulations for building design. A form-based code is a land-development regulation that fosters predictable built results by using physical form (rather than separation of uses) as the organizing principle for the code, and allows development to advance in a timely manner without additional review. Form-based codes seek to provide the appropriate balance between certainty of results for communities while providing a faster-build timeframe and increased flexibility for developers to adapt to changing market conditions.

## Developers have two options when proposing to build in Coffee Creek:

- 1. New form-based code process where developers submit projects that comply with all of the clear and objective code standards. Staff reviews these projects for conformance with the code, resulting in a faster process and greater certainty of outcome.
- 2. Traditional design review process where developers submit projects that do not meet all of the clear and objective code standards. These projects are subject to review and approval by the City's Development Review Board, and can take more time for all parties for review and modifications.

Development of the Form-based Code and accompanying Pattern Book began in 2013 and was funded by a grant from ODOT's Transportation and Growth Management Code Assistance Program. A Technical Advisory Committee, composed of committee members drawn from local jurisdictions, agencies, service providers, and stakeholders provided ongoing review, input, and guidance on the project.

Throughout summer and fall 2017, City staff engaged multiple public bodies—including the Development Review Board, Planning Commission and City Council—as well as Coffee Creek-area property owners, to seek feedback and finalize the draft Code.

Located to the northwest quadrant of Wilsonville near the Coffee Creek Correctional Facility, the 225acre Coffee Creek Industrial Area was brought into the greater Portland metro urban growth boundary in 2002, designated as a "Regionally Significant Industrial Area" exclusively for employment uses. In November 2015, Wilsonville voters approved establishing an urban renewal district, formed in 2016, to fund infrastructure that would be paid for by new taxes on new development in the employment zone. Initial plans estimate that the Coffee Creek Industrial Area can host 1,800 jobs with an estimated annual payroll in excess of \$55 million at build-out for general industrial, warehouse, flex, software engineering and research and development-related businesses.

## **Reports from City Boards and Commissions**

## City Council Approves Annexing County Roadway, Receives Top-Rated Annual Financial Audit Report and Discusses Traffic and Villebois Parks

uring the Jan. 4, City Council meeting, the Council approved on first reading the annexation into City limits of 4.9 acres of roadway located in the northwest industrial area of Wilsonville. Approximately one mile of existing rural and unimproved county roads were annexed, including Garden Acres Road, Cahalin Road and Clutter Street. The Council's action is the first step that is to be followed by transfer of the road authority from Washington County to the City in preparation for development of the regionally significant Coffee Creek industrial area.

The Council also heard a glowing report on the annual audit of the City's 2016-17 Comprehensive Annual Financial Report conducted by the certified public accounting firm, Merina & Company, LLP. Auditor Tonya Moffitt, CPA, reported that the City received a favorable audit with an unqualified opinion, which indicates that the financial statements are presented fairly, and users can rely on the material accuracy of the documents to evaluate the City's financial position. Results of the audit also demonstrate the City's compliance with state and federal financial laws.

Under Mayor's Business, the Council confirmed the appointment of Dave Pearson, Executive Director of the World of Speed Motorsports Museum, to the Tourism Promotion Committee, vacant position no. 1, with a term ending June 30, 2019.

Prior to the Council meeting in work session, the Council discussed issuing a joint letter with the Clackamas County Board of Commissioners to Oregon legislative leaders opposing potential legislation in the "short" February session of the legislature that would circumvent public-review processes to allow the Oregon Dept. of Aviation to 'supersite' an extension of the Aurora State Airport runway in Marion County. The Council directed staff to work with Clackamas County to oppose legislation that preempts public participation in the land-use process and results in increased urban-level activity in a rural location lacking municipal governance, adequate infrastructure and surface-transportation facilities.

The Council discussed an update on the Southbound I-5 Boone Bridge Auxiliary Lane Study, technically called an interchange facilities plan, that the City is undertaking with the Oregon Department of Transportation. The study is to quantify the cost and benefits of adding a new lane on the I-5 Boone Bridge over the Willamette River in order to mitigate traffic congestion between the I-5/Wilsonville Road and the I-5/Highway 551 interchanges; for more information see www.ci.wilsonville.or.us/I-5BooneBridge.

The Council also heard a report on the 15-year-long history of planning for regional parks numbers seven and eight that border the Coffee Creek wetlands located in the developing Villebois 'urban village' neighborhood. Several neighbors had raised concerns that they understood that the parks were to be left unimproved; however, long-term plans approved through prior public processes had determined that the parks would be partially developed with pathways, gazebos, children's play structures, a restroom, an open play area and a parking lot. The remaining 43 acres of the 55-acre park land are to be set-aside as a natural area that Metro regional government plans to rehabilitate ecologically by removing invasive species and restoring with native plants.

## City Council Approves I-5/Wilsonville Road Traffic Mitigation and Library Remodeling Projects, Seeks Metro Mediation on Basalt Creek Area Land Uses

t the Dec. 18, City Council meeting, the Council Aapproved two contracts for road-construction projects estimated at \$1 million designed to mitigate traffic congestion in the I-5/Wilsonville Road/Boones Ferry Road intersection area. The Council endorsed a contract to the low bidder, Kerr Contractors Oregon, Inc., in the amount of \$562,578 to modify the I-5/ Wilsonville Road interchange Exit 283 southbound freeway on-ramp. The project adds a third stacking lane to the metered I-5 on-ramp in order to increase capacity to hold an additional 25 vehicles waiting to enter the freeway during evening rush-hour.

The second traffic-mitigation project was awarded to Brown Contracting, Inc., for \$191,649 to reconstruct the southern, signalized entrance/exit to Old Town Square/Fred Meyer shopping center to include a second travel lane on northbound Boones Ferry Road between the exit/entrance and Wilsonville Road.

The Council approved a major remodeling project for the Wilsonville Public Library in the amount of \$1,054,000 to 2KG Contractors, Inc. Total library renovation costs, including a completely upgraded heating-air conditioning-ventilation (HVAC) system and new furniture, is estimated at \$1.35 million. The Library District of Clackamas County is contributing \$1 million to the project, with the balance of the remodeling costs originating from the City's general fund. The Council authorized an intergovernmental agreement with the City of Tualatin and Washington County for Metro regional government to mediate a land-use dispute between the Cities of Tualatin and Wilsonville over future proposed land-uses in a portion of the Basalt Creek Urban Growth Boundary (UGB) area that was designated in 2004 primarily for industrial employment. After receiving a \$350,000 Metro grant funded by a regional new-construction excise tax for concept planning of the area and agreeing initially on land-use designations in 2016, the City of Tualatin changed the proposed use of the Basalt Creek "Central Subarea" from the prior employment allocation to residential uses. Due to a number of concerns focused on inappropriate housing location and higher residential traffic, the Wilsonville City Council objected to the proposed change in land-use from employment to residential housing.

The Council authorized a contract to the Center for Transportation and the Environment (CTE) not to exceed \$120,000 that is fully reimburseable by the U.S. Dept. of Transportation, Federal Transit Administration (FTA). CTE is to assist the City's South Metro Area Regional Transit (SMART) agency successfully deploy new battery electric-powered buses funded by a \$1.45 million 2017 FTA "Low-No Emissions" program grant by analyzing transit routes and determining optimum bus configuration and charging infrastructure.

Under Mayor's Business, the Council authorized a two-year contract extension for Municipal Court Judge Fred Weinhouse whose work has been considered exceptional.

The Council also discussed proposed legislation in the "short" February session of the Oregon legislature that would remove public-review processes and allow the Oregon Dept. of Aviation to 'supersite' an extension of the Aurora State Airport runway in Marion County. The Council directed staff to work with Clackamas County to oppose the proposed legislation that preempts public participation in the land-use pro cess and results in increased urban-level activity in a rural location lacking municipal governance, adequate infrastructure and surface-transportation facilities. Prior to the Council meeting in work session, the Council heard reports on items to come before Council that evening and considered other matters. The Council discussed the pros and cons of using a \$1.55 million federal Metropolitan Transportation Investment Program grant awarded competitively through Metro in February 2017 for the proposed \$10 million I-5 Pedestrian & Bikeway Bridge project. Since the time of the grant award, City staff project that both federal and state alternative-transportation grantfunding opportunities are declining, while 'federalizing' the project creates additional staff work, costs overhead and extra City obligations not required if only local funds are used. The Council also discussed options for installing 'red-light' cameras in the I-5/Wilsonville Road/ Boone Ferry Road intersection area to deter running red lights and blocking intersections that create traffic congestion and imperil public safety.

The Commission is to consider whether to recommend adoption of the amendment to the City Council, which is scheduled to hold a public hearing on the proposal on March 5.

## Voters to See TVF&R Annexation Measures on March Ballot Measures 34-280 and 34-281 Would Allow Newberg and Rural Area to Join Fire District

W ilsonville voters are to be asked in the March 13 special electron **V** 13 special election to consider whether to allow annexation of the City of Newberg and Newberg Rural Fire Protection District territories into Tualatin Valley Fire & Rescue's service area.

Approval of Measures 34-280 and 34-281 does not increase taxes paid by existing TVF&R residents. Because property owners in Newberg and the surrounding rural area would pay the same rate upon annexation as existing TVF&R patrons, the tax rate paid on bonded debt could actually decrease across TVF&R's entire service area.

Since July 1, 2016, TVF&R has provided fire protection, emergency medical and ambulance transport services to the city of Newberg and surrounding rural area under a two-year

contract. Voters residing in both the City of Newberg and Newberg Rural areas voted in favor of annexation to TVF&R in the November 2017 election, with 69 percent voter support in the city and 63 percent voter approval in the rural area.

Oregon law allows 100 or more existing TVF&R voters to file petitions with Washington County dur-

ing the annexation process to request an in-district election on the proposed annexations. In December, petitions were filed and accepted by the Washington County board.

> Since then, TVF&R has placed Measures 34-280 (city) and 34-281 (rural) on the March ballot. If voters pass both Measures 34-280 and 34-281, TVF&R then finalizes the annexation process. The City of Newberg and Newberg Rural Fire Protection District would then permanently join TVF&R on July 1, 2018. Property owners in the city of Newberg and Newberg Rural would pay the same tax rate as existing TVF&R property taxpayers.

If either or both measures do not pass, TVF&R plans to work with Newberg and/or the rural district to ensure

an effective transition, whether TVF&R continues to provide service through a contract extension or if Newberg reverts to the former model of service provision.

SMART intends to continue to expand employerbased commute services to ensure Wilsonville employers and employees have the resources and opportunities they need to thrive.


