In drafting the TIS for both Frog Pond Crossing and Frog Pond Oaks, the City's consultant relied upon ODOT's Development Review Guidelines that has a 50 trip threshold to trigger analysis of ODOT intersections. The Frog Pond Crossing development generates a total of 30 trips, with 2 of those trips expected to travel through both I-5 interchanges. Therefore, by the review guidelines, not additional analysis was provided. If ODOT has revised the Development Review Guidelines to identify a lower trip threshold that would trigger analysis, please let me know.

As part of the Frog Pond West Master Planning effort, the two I-5 interchanges were evaluated to determine TRP (page 47 of the Master Plan: <a href="https://www.ci.wilsonville.or.us/planning/page/frog-pond-master-plan">https://www.ci.wilsonville.or.us/planning/page/frog-pond-master-plan</a>) and both interchanges were found to meet ODOT standards under 20-year horizon analysis at the interchanges. The current number of trips being generated by all of the Frog Pond traffic studies to date are well below the number of trips that were analyzed as part of the full Master Plan.

Given this information, the City does not anticipate future Frog Pond West traffic studies including analysis of these interchanges unless triggers by the 50 trip threshold in the review guidelines.
