## WHAT IS THE PURPOSE OF THE AGREEMENT?

he loss of wetland and floodplain areas along with an increase in impervious surfaces necessitates the active management of stormwater runoff. Through the use of structural controls, such as water quality facilities and detention ponds, or other management measures within most urbanized areas these losses can be mitigated.



Federal, state and local agencies created management regulations and guidelines so as to improve stormwater quality and protect watersheds, rivers, streams and drinking water resources.

## WHY AM I REQUIRED TO HAVE AN AGREEMENT?

Anytime there is new development or new ownership of a property with a stormwater facility, built in accordance with the City of Wilsonville's Public Works Standards, it is required to be maintained following these Public Works maintenance standards.

## WHAT AM I REQUIRED TO DO UNDER THE MAINTENANCE PLAN?

- Annual maintenance on storm drainage facilities in conformance with City of Wilsonville's Public Works Standards (see page 4).
- Removal of debris, leaves and sediment from manholes, detention outlet structures, and catch basins.
- Disposal of all oils, sediment and debris in an approved dumpsite.
- Replacement of all dead or dying plants in ponds and swales. Maintenance on original plantings.
- Removal of trash from ditches, swales, catch basins, or any stormwater conveyance.



## WHY SHOULD I CARE ABOUT MAINTAINING MY STORMWATER FACILITY?

People and their actions are the most significant sources and causes of urban runoff and pollution.

Uncontrolled or untreated stormwater from the urban environment and from construction activities can runoff the landscape into surface waters. This runoff can include such pollutants as sediments, pathogens, fertilizers/nutrients, hydrocarbons, and metals. Pavement and compacted areas, roofs, and reduced tree canopy and open space increase runoff volumes that rapidly flow into our waters. This increase in volume and velocity of runoff often causes stream bank erosion, channel incision and sediment deposition in stream channels. In addition, runoff from these developed areas can increase stream temperatures that along with the increase in flow rate and pollutant loads negatively affect water quality and aquatic life.
