## **ORDINANCE NO. 541**

## AN ORDINANCE AMENDING WC 2.314(14) TO CORRECT AND CLARIFY LANGUAGE REGARDING PERSONAL SERVICES CONTRACTS.

WHEREAS, Ordinance No. 511 amending WC 2.314 was enacted October 18, 1999; and

WHEREAS, Ordinance No. 511 added Section 2.314(14) to the Wilsonville Code, which reads in its entirety as follows:

- "(14) Unless otherwise provided in WC 2.310-2.314 all personal services contracts for which the fee is anticipated to exceed \$50,000 will be awarded based on a competitive selection process except for the following:
- (a) Emergency requirements precluding completion of a competitive selection process;
- (b) Selection from a list of consultants with similar qualifications in which selection is determined based on an annual qualification process; and
- (c) Follow on work where a change in consultants would clearly result in increased costs or increased time.

WHEREAS, the intent of WC 2.314(14) was that any one of the conditions identified in 2.314(14)(a)(b) or (c) is to be considered an exception and not that all three conditions must be met; and

WHEREAS, the use of the conjunction "and" could be interpreted as requiring that all three conditions need to be met; and

WHEREAS, simply replacing "and" with "or" in (14)(b) would clarify that any one of the three conditions provided an exception.

## NOW, THEREFORE, THE CITY OF WILSONVILLE ORDAINS AS FOLLOWS:

- A. The City Council adopts the above recitals as findings and incorporates them by reference in support of this Ordinance.
  - B. WC 2.314(14) shall be amended to read:
  - "(14) Unless otherwise provided in WC 2.310-2.314 all personal services contracts for which the fee is anticipated to exceed \$50,000 will be awarded based on a competitive selection process except for the following:

- (a) Emergency requirements precluding completion of a competitive selection process or;
- (b) Selection from a list of consultants with similar qualifications in which selection is determined based on an annual qualification process; or
- (c) Follow on work where a change in consultants would clearly result in increased costs or increased time.
