

ORDINANCE NO. 564

AN ORDINANCE OF THE CITY OF WILSONVILLE AMENDING WILSONVILLE CODE SECTIONS 5.000, 5.020, AND 1.013, CONCERNING APPLICATION OF THE MOTOR VEHICLE CODE IN THE CITY, AND THE MANNER IN WHICH VIOLATIONS ARE ENFORCED AND THE PENALTIES THEREFOR.

WHEREAS, the City of Wilsonville has adopted the Oregon Vehicle Code and state statutory procedure for violation enforcement, and,

WHEREAS, the since that time, the Oregon Legislature has enacted amendments to state law respecting the Oregon Vehicle Code, traffic fines imposed under that Code and the manner in which violations are enforced, and,

WHEREAS, it is necessary and in the public interest to conform the local code to changes in state law,

NOW THEREFORE, THE CITY OF WILSONVILLE ORDAINS AS FOLLOWS:

Section 1. That Wilsonville Code section 5.000 is hereby amended as follows:

5.000. State Laws Applicable.

The laws of the State of Oregon governing the operation of motor vehicles ~~which are in effect at the time this Code becomes effective, together with all amendments which may hereafter be enacted~~ contained in the Oregon Vehicle Code, as defined in ORS 801.010, are hereby adopted and made applicable inside the City as part of this Code. All motor vehicles operated in the City shall be operated in accordance with the laws of the State of Oregon and the provisions of the Wilsonville Code. Any person who operates a motor vehicle contrary to the laws of the State or Wilsonville Code, shall be guilty of a violation of Section 5.000 to 5.254.

Section 2. That Wilsonville Code section 5.020 is hereby amended as follows:

5.020. Violation and Penalty.

Violation of this Chapter and the Oregon Laws which are adopted by reference shall be punished upon conviction **as provided in Oregon Law or, if not so provided,** as designated below in Section 5.300.

Section 3. That Wilsonville Code section 1.013 is hereby amended as follows:

1.013. Violation Enforcement.


