## **ORDINANCE NO. 648**

AN ORDINANCE OF THE CITY OF WILSONVILLE APPROVING A ZONE MAP AMENDMENT FROM THE CITY PUBLIC FACILITY (PF) AND CLACKAMAS COUNTY EXCLUSIVE FARM USE (EFU) ZONE TO THE VILLAGE (V) ZONE AND ADOPTING A ZONING ORDER ON APPROXIMATELY 23.48 ACRES IN WEST PORTION OF VILLEBOIS VILLAGE ON TAX LOT 2996 AND PORTIONS OF TAX LOTS 2906 and 2908, SECTION 15, T3S-R1W, CLACKAMAS COUNTY, OREGON. WEST HILLS DEVELOPMENT (DEVELOPER)/ VILLEBOIS LLC APPLICANT.

WHEREAS, On April 14, 2008, Panel A of the Development Review Board reviewed a Zone Map Amendment (File No. DB07-0089); Preliminary Development Plan – Phase 1 (File No. DB07-0087); Tentative Subdivision Plat (File No. DB07-0088); Final Development Plan (File No. DB07-0090) and Type 'C' Tree Plan (File No. DB08-0004).

WHEREAS, the DRB recommended approval of the proposed zone change, and of the above described case file, with no conditions, and,

WHEREAS, on April 14, 2008, the DRB Panel A, after proper legal notification, conducted a public hearing to review the items, reviewing the materials submitted by the applicant and after reviewing the record, the materials, taking public testimony, and after deliberation, adopted Resolution Number 128, recommending approval to council of the zone change, with no conditions, and

WHEREAS, after proper legal notification the City Council scheduled a public hearing on the matter, and

WHEREAS, the Council opened the public hearing, took testimony and evidence from interested parties on the above-referenced zone change application, and upon consideration of the entire record herein, determines that the application meets applicable approval criteria.

NOW, THEREFORE, THE CITY OF WILSONVILLE ORDAINS AS FOLLOWS:

Section 1. <u>Finding</u>. The City Council adopts as findings and conclusions the forgoing recitals and the staff report in this matter dated April 14, 2008, labeled Exhibit A1, which Exhibits are attached hereto and incorporated herein as if fully set forth.

Section 2. Zoning Order. The official City of Wilsonville Zone Map is hereby amended in Zoning Order DB07-0089, attached hereto, Wilsonville Zone Map classification: *Public Facility (PF)* and Clackamas County Zone Map classification: *Exclusive Farm Use (EFU)*. Rezone the subject property to the *Village (V)* zone on Tax Lot 2996 and portions of Tax Lots 2906 and 2908, Section 15, T3S-R1W, Clackamas County, Oregon, as depicted on the attached map (Attachment 1), Clackamas County, Wilsonville, Oregon and described in attached legal description (Attachment 2).

It appears to the Council that the property, which is the subject of this application, is described as follows: Tax Lot 2996 and portions of Tax Lots 2906 and 2908 in Section 15, T3S-R1W, Clackamas County, Wilsonville, Oregon, and such property has heretofore appeared on the City Zoning Map as *Public Facility (PF)* and on the Clackamas County Zoning Map as *Exclusive Farm Use (EFU)*.

The Council having heard and considered all matters relevant to the application, including the Development Review Board record and recommendation, finds that the application should be approved, and it is therefore,

ORDERED that approximately 23.48 acres of Tax Lot 2996 and portions of Tax Lots 2906 and 2908, in Section 15, T3S-R1W, Wilsonville, Clackamas County, Oregon, more particularly shown in proposed zone map amendment map, Attachment 1 and described in Attachment 2 to this order, is hereby rezoned *to Village (V)*, and such rezoning is hereby

declared an amendment to the Wilsonville Zoning Map (Section 4.102 WC) and shall appear as such from and after entry of this Order.




