ORDINANCE NO. 51

AN ORDINANCE AMENDING AND INCREASING BUSINESS LICENSE FEES AND PROVIDING AN EFFECTIVE DATE.

THE CITY OF WILSONVILLE ORDAINS AS FOLLOWS:

Section 1: Section 3 (B) of the Wilsonville Business Licensing Ordinance No. 10 enacted October 20, 1969, and amended by Ordinance No. 37 enacted June 25, 1973, is hereby amended and changed to provide as follows:

" Section 3:

B. The annual license fee for each fiscal year commencing July 1, 1975, and payable on or before July 15th shall be \$100.00 plus \$3.00 per each employee which is actively engaged in the City in his employer's business, except, however, that if a business has an annual net income of \$12,000.00 or less, the annual license fee shall be \$50.00 plus \$3.00 per each employee."

Section 2: This Ordinance shall take effect and the increased license fees shall be applied commencing at the hour of 12:01 o'clock a.m., Oregon Daylight Saving Time, on Tuesday, July 1, 1975.

Passed on first reading at a regular meeting of the Wilsonville City Council held on the 9th day of June, 1975; ordered posted in three (3) public and conspicuous places in the City of Wilsonville for a period of five (5) consecutive days as required by the Wilsonville City Charter, and to come up for final reading and action of the Wilsonville City Council at a regular meeting thereof to be held on the 23rd day of June, 1975, at the hour of 7:30 o'clock p.m., Oregon Daylight Saving Time, at the Wilsonville City Hall.
