ORDINANCE NO. 107

AN ORDINANCE AUTHORIZING PAYMENT OF BILL FOR EMERGENCY REPAIRS OF CITY WATER PUMP

WHEREAS, the City's Water Pump on the main well failed to function in May of this year, requiring purchase of materials and repairs. Materials were purchased from MITCHELL, LEWIS AND STAVER CO., Portland, Oregon, and repairs were made by SCHNEIDER BROTHERS, St. Paul, which were the best available and most qualified companies to provide emergency service and there was insufficient time to call for bids; and

WHEREAS, the required repairs were made promptly thereby averting a water shortage, which would have seriously affected the health and general welfare of the City and its residents; and the costs of the materials totaled \$9,825.99, which should be paid; and the costs of the repairs totaled \$7,195.80 which should be paid; now therefore,

THE CITY OF WILSONVILLE ORDAINS AS FOLLOWS:

Section 1: The statement of MITCHELL, LEWIS AND STAVER CO. of Portland, Oregon in the amount of \$9,825.99 for factory shipment on May 29, 1978 of repair parts for the City's Worthington Vertical Water Pump and the repairs made by SCHNEIDER BROTHERS, St. Paul in the amount of \$7,195.80 are approved for payment with funds in the City's 1977-78 Water Department, which have been transferred for settlement of the account; and the actions of City Staff and Officers in ordering and making the necessary repairs is hereby ratified and confirmed.
