


- WILSONVILLE POST OFFICE

ORDINANCE NO. 182

AN ORDINANCE AMENDING ORDINANCE NO. 70, PRESCRIBING THE METHODS AND PROCEDURES FOR MAKING PUBLIC IMPROVEMENTS IN THE CITY OF WILSONVILLE, ETC., AND DECLARING AN EMERGENCY.

THE CITY OF WILSONVILLE ORDAINS AS FOLLOWS:


Section 1: Amendment of Section 15 of Ordinance No. 70.

The City Council of the City of Wilsonville amends "Section 15: Lien Records and Foreclosure Proceedings." by deleting the sentence "Interest shall be charged at the rate of eight percent (8%) per annum until paid on all amounts not paid within 30 days from the date of the assessment Resolution." and to replace said sentence with the following language: "Interest shall be charged at such rate per annum as shall be determined by the City Council on all amounts not paid within 30 days from the date of the assessment resolution."


Section 2: An emergency is hereby declared based on a finding that warrants will be coming due in the near future on two local improvement district projects and it is in the general interest of the citizens of Wilsonville to have Ordinance No. 70 amended as set forth above prior to the time of the warrants coming due.

Submitted to the Council and read the first time at a regular meeting thereof on the 4th day of May, 1981, and

scheduled for second reading at a regular meeting of the Council on the 18th day of May, 1981, commencing at the hour of 7:30 o'clock p.m., at the Wilsonville City Hall.
