ORDINANCE NO. 208

AN ORDINANCE AMENDING SECTION 4.051 OF THE WILSONVILLE CODE, 1981.

THE CITY OF WILSONVILLE ORDAINS AS FOLLOWS:

Section 1: Section 4.051(1)(c) is hereby amended by adding the following subsection 7:

- 7. Upon review and approval by the Planning Director, temporary directional signs to said individual lots shall be permitted for a period of up to six (6) months upon a showing of a decline in the economy, and more specifically, in the housing development industry, that would indicate the need for temporarily easing real estate sign restrictions in an attempt to revitalize the housing market. The signs would be permitted with approval of the Planning Director in accordance with the following standards:
 - a. A limit of three off-site signs per development with all signs located on private property at or near street intersections.
 - b. Maximum sign area of six square feet per sign.
 - c. The applicant submits a permit fee of \$25, together with a map identifying the location of the placement of each sign and the authorization of the owner of the property on which the sign is to be located.

Such permission may be reinstated for a further six (6) months upon a showing of good cause."

Section 2: In the interest of the general health and welfare of the citizens of the City of Wilsonville, that this Ordinance be put into effect immediately, an emergency is hereby declared.
