ORDINANCE NO. 219

AN ORDINANCE AMENDING CHAPTER 4, PLANNING, OF THE WILSONVILLE CODE 1982 AND DECLARING AN EMERGENCY.

WHEREAS, on May 3, 1982, the City Council adopted Ordinance No. 210 thereby amending Chapters 2 and 4 of the Wilsonville Code as recommended by the Planning Commission for compliance with the LCDC Continuance Order issued October 30, 1981, and

WHEREAS, said revised Code, together with the revised Com prehensive Plan and supporting documentation, were submitted to LCDC for acknowledgment review on July 8, 1982, and

WHEREAS, the City's Comprehensive Plan has been scheduled for consideration before LCDC on August 19 and 20, 1982, and in preparation for said review, LCDC has cmpleted a staff report on said Plan and supporting documents, and

WHEREAS, based on objections received and department policy (St Helen's Housing Policy), the Department has found that section 4.136(3) of the Wilsonville Code contains language that violates the St. Helen's Housing Policy requiring clear and objective approval standards, and therefore, has recommended to the Commission continuance of the acknowledgment review until such time as the language is amended in compliance with the St. Helen's Policy, and

WHEREAS, the City Council finds it necessary to amend Section 4.136(3) WC in order to obtain LCDC acknowledgment.

NOW, THEREFORE, the City of Wilsonville ordains as follows: Section 1, Chapter 4, Planning, of the Wilsonville Code, 1982, attached hereto as Exhibit A is hereby amended to read as follows:

> 4.136(3) The Commission shall, in making its determination of compliance in attaching Conditions, consider the effects of this action on the availability and cost of needed housing. The provisions of this section shall not be used in such a manner that additional conditions, either sigularly or accumulatively, have the effect of unnecessarily increasing the cost of housing or effectively excluding a needed housing type. However, consideration of these factors shall not prevent the Commission from imposing Conditions of Approval necessary to meet the minimum requirements of the Comprehensive Plan and Code.

Inasmuch as this Ordinance is necessary for the immediate perservation of the health, safety and general welfare of the City of Wilsonville and the inhabitants thereof, an emergency is hereby declared to exist and this Ordinance shall take effect immediately upon its final passage by the City Council and signing by the Mayor.

Submitted to City Council and read for the first time at a regular meeting thereof on the 2nd day of August, 1982, and scheduled for second reading at later date meeting of the City Council on the 16th day of August, 1982, commencing at the hour of 7:30 P.M. at the Wilsonville Wesleyan Church.
