## ORDINANCE NO. 222

AN ORDINANCE ADOPTING PREVIOUS TRAFFIC CONTROL COMMISSION'S ORDER NO. 1 AS A SPECIAL ORDINANCE OF THE CITY OF WILSONVILLE.

WHEREAS, the City Council of the City of Wilsonville has determined that it is in the best interests of the welfare and public safety of its citizens to reorganize the Traffic Control Commission into the Traffic Safety Commission, and said commission will no longer be authorized to adopt orders governing traffic matters; and

WHEREAS, said reorganization therefore necessitates the adoption of previous adopted orders as ordinances; and

WHEREAS, those orders dealing with parking and traffic signing regulations for particularized geographic areas shall be adopted as special ordinances, and those orders dealing with comprehensive traffic regulations shall be adopted as general ordinances, and shall be codified;

NOW, THEREFORE, the City of Wilsonville Ordains as follows:

- 1. It is hereby declared that Traffic Control Commission Order No. 1 shall be a special ordinance of the City of Wilsonville.
- 2. There shall be no parking of any type of vehicle or conveyence on the west side of Montebello Drive, only passenger vehicles may park on the east side of Montebello Drive, and there shall be no parking or stopping of any type of vehicle whatsoever in or on Montebello Drive for a distance of 50 feet from its intersection with Wilsonville Road.

- 3. Appropriate signs shall be erected and other markers placed to give notice of the regulations set forth in paragraph 2 above.
- 4. "Passenger vehicles" shall not include any campers, motor homes, travel trailers, or motor trucks as those terms are defined in ORS 481.021 and 481.035.
- 5. It being determined by the Wilsonville City Council an emergency exists, this Ordinance shall take effect immediately upon final reading and passage by the Wilsonville City Council.
