RESOLUTION NO. LXXVII (77)

A RESOLUTION APPROVING ENGINEER'S REPORT FOR "CANYON CREEK AND BOECKMAN ROADS LID #1--MUNICIPAL WATER"; DECLARING COUNCIL'S INTENTION TO MAKE IMPROVEMENTS; PRESCRIBING THE MANNER AND METHOD FOR CARRYING OUT THE IMPROVEMENT; FIXING A TIME FOR A PUBLIC HEARING; AND DIRECTING THE CITY RECORDER TO GIVE NOTICE OF SUCH IMPROVEMENT AND PUBLIC HEARING.

WHEREAS, the Wilsonville City Council adopted Resolution
No. LXVII (67) on October 20, 1975, which declared the Council's
intention to make improvements to provide municipal water to
residents of Canyon Creek Road and Boeckman Road in accordance
with the provisions of City Ordinance No. 30 enacted August 28,
1972, entitled "AN ORDINANCE PRESCRIBING THE METHODS AND PROCEDURE
FOR MAKING PUBLIC IMPROVEMENTS IN THE CITY OF WILSONVILLE, FOR
LEVYING AND COLLECTING SPECIAL ASSESSMENTS THEREFOR, AND FOR THE
CREATION AND ENFORCEMENT OF ASSESSMENT LIENS; AND DECLARING AN
EMERGENCY." Said Resolution also authorized the engineering firm
of Westech Engineering, Inc. of Salem, Oregon, to make a survey
and written report of the project; and

WHEREAS, the engineer's report dated November 26, 1975, was revised May 27, 1976, and submitted June 3, 1976, and filed with the Wilsonville City Recorder; and

WHEREAS, the engineer's report has been reviewed by the Council and was found to contain all of the information as required by Section 2 of said Ordinance No. 30 and was approved as submitted by motion of the Council at a regular meeting thereof on Monday, June 14, 1976; now, therefore,

BE IT RESOLVED by the Wilsonville City Council that:

1. The Council hereby reaffirms and declares its intention to make improvements to the City's municipal water system for the extension of City water lines to serve the properties in the City which are on Boeckman Road and Canyon Creek Road, and that such local improvement project be carried out in accordance with the provisions of City Ordinance No. 30 so that the costs of such project can be assessed to the benefited properties and financed under the

provisions of the Bancroft Bonding Act; and

- 2. A public hearing to consider objections to and remonstrances against the proposed project is hereby set to be held at the FAITH BAPTIST CHURCH at 7805 S.W. Boeckman Road in Wilsonville, Clackamas County, Oregon, commencing at 8:00 o'clock p.m. on Monday, June 28, 1976, and the City Recorder is hereby directed to give at least ten (10) days' notice of such proposed improvement and public hearing thereon by posting a Notice at the Wilsonville City Hall and at two (2) places within the benefited area and by mailing copies of such Notice to the owners of the property to be assessed for the costs of such improvements. Said Notice shall contain the information as required by Section 4 of City Ordinance No. 30; and
- 3. The construction work for said improvement project shall be done on contract according to Plans and Specifications which would be prepared by qualified engineers and approved by the City Council and providing that there are not sufficient remonstrances or other reasons which would require or justify the abandonment of the project.
