## RESOLUTION NO. CXV (115)

A RESOLUTION APPROVING ENGINEER'S REPORT FOR BOECKMAN CREEK SEWER IMPROVEMENT PROJECT (LID #3); DECLARING INTENTION TO MAKE SUCH IMPROVEMENTS; PROVIDING THE MANNER AND METHOD OF CARRYING OUT THE IMPROVEMENTS; AND SETTING A TIME FOR A PUBLIC HEARING TO CONSIDER REMONSTRANCES.

WHEREAS, the Wilsonville City Council adopted its Resolution No. CXI (111) at a regular meeting on March 5, 1979, which was entitled "A RESOLUTION APPROVING OWNERS' REQUEST TO FORM A SEWER IMPROVEMENT DISTRICT AND DIRECTING CITY ENGINEER TO MAKE A SURVEY AND WRITTEN REPORT"; and

WHEREAS, the Owners/Petitioners made a cash deposit of \$1,500 which was the amount determined by the City's Engineer as reasonably necessary to defray the City's costs of administration, survey, design, preliminary engineering, mapping, and any other actions necessary to the processing of the request; and

WHEREAS, Westech Engineering, Inc. of Salem, Oregon, prepared its report entitled "Boeckman Creek Trunk Sewer - L.I.D." dated March 1979, which was filed with the City Recorder on March 14, 1979, and was reviewed, considered and approved at a regular council meeting on March 19, 1979; and , WHEREAS, the Engineer's Report as required and requested, and reviewed and approved by the council on March 19, 1979, conforms to the requirements of the council and Ordinance No. 70; now, therefore,

BE IT RESOLVED by the Wilsonville City Council that:

(1) The report of Westech Engineering, Inc. dated March 1979, and filed with the Wilsonville City Recorder on March 14, 1979, and entitled "BOECKMAN CREEK TRUNK SEWER - L.I.D." is approved.

(2) The council hereby declares its intention to make the improvements as described in the Engineer's Report and such improvement project shall be known as the "BOECKMAN CREEK SEWER IMPROVEMENT DISTRICT (LID #3)".

(3) The project shall be accomplished by a construction contract to be awarded to a successful bidder if there are not sufficient objections made by the owners of the property to be assessed for the costs after

hearing on the notice of such improvement, which is required by Ordinance No. 70, and hereinafter provided for; and

(4) A public hearing to consider remonstrances against the proposed project is hereby set to be held at the Wilsonville Grade School in Wilsonville, Oregon, commencing at 8:00 o'clock P.M., or as soon thereafter as the time schedule permits, on Monday, May 7, 1979; and the City Recorder is hereby directed to give notice of such improvement project and public hearing by posting, at the City Hall, and at two places within the benefited area, and by mailing of copies of such notice to the owners of the property to be assessed for the costs of such improvement, as required by Section 4 of Ordinance No. 70.
