RESOLUTION TO AUTHORIZE CONSTRUCTION CONTRACT WITH J. D. MECHANICAL, INC. FOR A MUNICIPAL WATER WELL PUMP AND PUMP STATION AT THE WIEDEMAN ROAD SITE.

WHEREAS, the City of Wilsonville has heretofore advertised for and received bids which were opened at the City Hall on April 1, 1981, for construction of a new municipal water well pump and pump station at the Wiedeman Road site near Tektronix; and

WHEREAS, the plans and specifications for said project were prepared by the City's engineers, Westech Engineering, Inc., of Salem, Oregon, and calls for bids were duly and regularly published in the manner and for the time required by law; and

WHEREAS, the bids were publicly opened and read aloud at the Wilsonville City Hall on April 1, 1981, and the results of the bidding were reported to the Mayor and the Wilsonville City Council by letter of C. H. Steketee, Project Manager of the City Engineers, dated April 2, 1981, and said letter report and bids were considered by the Wilsonville City Council/Contract Review Board at its regular meeting on Monday, April 6, 1981. There were a total of ten bids received, as follows:

WHEREAS, the Wilsonville City Council/Contract Review Board has considered the bids, the plans and specifications for said project, the contract documents generally, the reports and recommendations of its Engineer and City staff, and determined that the low bid is that of J. D. Mechanical, Inc. for the bid amount of \$94,719.00.

NOW, THEREFORE, IT IS HEREBY RESOLVED BY THE CITY OF WIL-SONVILLE, as follows:

1. The bid of J. D. Mechanical, Inc., for construction of a municipal water well pump and pump station at the Wiedeman Road site near Tektronix in the total amount of \$94,719.00 is hereby accepted as is recommended in the April 2, 1981, letter to the Mayor and the City Council from the City's engineering firm for the amount of the contract for the construction of said project according to the plans and specifications as prepared by Westech Engineering, Inc.

- 2. The Mayor and City Recorder are authorized and directed to make, execute and deliver in the name of the City of Wilsonville and on its behalf the contract with J. D. Mechanical, Inc. for construction of a municipal water well pump and pump station at the Wiedeman Road site near Tektronix according to the plans and specifications therefor, and any changes or modifications of those plans and specifications as may be approved by the City Council and which said plans and specifications are now on file in the office of the City Recorder.
- 3. Payment by the City of Wilsonville of the construction contract authorized by the foregoing section 2 is to be made according to the schedule for payments as outlined in the contract documents.
- 4. In order that the construction work for the improvement project may be commenced as soon as possible and in order to prevent any possible water shortages for the citizens of the City of Wilsonville this Summer, an emergency is hereby declared to exist and this resolution is hereby adopted by the Wilsonville City Council at a regular meeting thereof on the 20th day of April, 1981.
