Gentlemen:

Enclosed is Change Order #1 proposed for the well project. This Change Order, deals with four changes as follows:

- 1. We found that we had to delete the angle gear drive and drive shaft arrangement because the City's tractor doesn't have sufficient power to run the pump. In addition, the angle gear drive and drive shaft assembly is a long delivery item and, if included, the pump station very likely would not be ready for service this summer.
- 2. At the request of the Tektronix engineers, the siding on the building ok. 8. is specified to match the Tektronix building #83. The price received from the manufacturer of the siding on the Tektronix building seemed extremely high. We were able to check with other manufacturers and find an identical siding at a considerable savings.
- 3. At the connection of the 10" pipeline to the existing 14" pipeline on Parkway, some interference between various underground utilities was encountered and this resulted in having to install additional fittings.
- 4. We were notified just before the start of construction that NW Natural Gas Company has a cathotic protection anode field immediately adjacent to the pipeline route. Consequently, we moved the pipeline approximately 15' to the north to avoid conflict. This added approximately 15' of pipe.

EXHIBIT A

We recommend that the Change Order be approved. The Change Order form should be available from the Contractor in a few days and needs to be signed by the City then. The project as a whole is progressing well. The pump is scheduled for delivery on the 15th of June and we expect to have the pump available for delivery of water to the distribution system by July 15.
