Acceptance Agreement Contract

This agreement entered into this /9 day of October 1981 between the City of Wilsonville, herein after referred to as City and Willamette Factors, Inc. an Oregon corporation, herein after referred to as Owner is for the purpose to settle amiably and to compromise differences which have arisen between the parties as to the necessity of effectuating certain repairs to utility systems within the Charbonneau Village planned development, Wilsonville, Oregon, determining the part and future responsibility for same, together with apportioning of the costs for same between the parties.

The parties have reached an accord in these matters without any admission of liability on the part of either party as follows:

Utilities Acceptance

The Owner in the interest of promoting good relation between the parties and the City, have agreed to the repairs, and their costs shall be accomplished and born by the respective parties as follows:

- The above Wastewater System Repairs and Storm Drainage Repairs shall be made and paid for by (Owner) Willamette Factors, Inc., subject to paragraph 5 below.
- The above Street System Repairs shall be made by the City and an amount equal to that set forth opposite each of the above listed items totaling \$6,130.00 shall be paid to the City by the Owner.
- The City formally accepts the Utilities system subject to paragraph 5 below located in public easements or public right-of-ways in the following areas:

 - Charbonneau "B" 2. Neighborhood
 - "C" 3. Charbonneau Neighborhood
 - "E" 4. Charbonneau Neighborhood
 - "F" 5. Charbonneau Neighborhood

 - 7. Charbonneau Single Family East First Addition
 - 8.
 - Charbonneau Single Family East Charbonneau French Prairie Rd. See Exhibit A 9.
 - 10. The Platted and improved streets including: (See Exhibit B)
 - Fairway Drive
 - Boones Bend
 - Molalla Bend (Accepted when repairs are completed)
 - d. Armitage Road
 - e. Armitage Court
 - Lake Point Court from Fairway Drive to Middle Greens Road f.
- By the execution of this agreement and the acceptance of the utilities as set forth in the preceding paragraph, neither party admits or otherwise agrees that either thereof has a duty or obligation between themselves to make the corrective repairs or nreplacements as set forth above and that the purpose of this agreement is strictly to avoid extensive, protracted, and expensive litigation. The Owner shall complete all repairs which it has assumed hereby within 30 days from the signature of this agreement by both the Owner and City. If weather conditions are determined to be unsatisfactory by the City to do the repairs, repairs can be postponed until weather will permit repairs to be made.
- All utility repairs completed by the Owner shall be done in ac-5. cordance with the City of Wilsonville's Public Work Standards, and shall be inspected and approved by the Director or his representatives at no cost to the owner.
