RESOLUTION NO. 208

A RESOLUTION MODIFYING AND APPROVING ENGINEERS REPORT AS MODIFIED FOR KINSMAN ROAD IMPROVEMENT PROJECT (L.I.D. #4), DECLARING THE INTENTION TO MAKE SUCH IMPROVEMENTS AS MODIFIED; PROVIDING THE MANNER OF CARRYING OUT THE IMPROVEMENTS AND SETTING A TIME FOR PUBLIC HEARING TO CONSIDER REMONSTRANCES.

WHEREAS, on October 15, 1979, the City Council adopted Resolution No. CXXIX (129) entitled " A RESOLUTION DECLARING INTENTIONS TO PROCEED WITH THE CONSTRUCTION OF KINSMAN ROAD IMPROVEMENT IN KINSMAN ROAD IMPROVEMENT DISTRICT (LID #4); ADOPTING ENGINEER'S REPORT AS FILED AND DIRECTING THE PREPARATION OF DETAILED PLANS, SPECIFICATIONS AND COST ESTIMATES; and

WHEREAS, the owners of over 50% of the property to be benefited have requested certain modifications to the project and the City generally being in accord with said modifications did cause Westech Engineering, Inc. to prepare an engineer's report, and an engineer's report updated as of December 1, 1981, was duly filed and presented to a regularly scheduled meeting of the City Council on December 7, 1981, together with a summary of recommendations presented by the Director of Public Works dated December 2, 1981, and

WHEREAS, the City Council did accept the engineer's report with modifications as outlined in Section V. Other Utilities of the Public Works Director's summary of recommendations and the Council has caused the reports and the summary to be placed on file with the Office of City Recorder;

BE IT RESOLVED by the Wilsonville City Council that:

(1) The report of Westech Engineering, Inc. of Salem, Oregon, filed with the Wilsonville City Recorder on December 2, 1981, modified by the City

Council on December 7, 1981, and entitled "KINSMAN ROAD LOCAL IMPROVEMENT DISTRICT" updated December 1, 1981, street improvements, including street construction, drainage facilities, underground power and telephone facilities, water lines, street lighting, and sanitary sewer line, is approved.

- (2) The Council hereby declares its intention to make the improvements as described in the engineer's report as modified and such improvement project shall be known as the "KINSMAN ROAD LID #4."
- (3) The project shall be accomplished by a construction contract to be awarded to a successful bidder if there are not sufficient objections made by the owners of the property to be assessed for the costs after hearing on the notice of such improvement which is required by Ordinance No. 70, and hereinafter provided for and provided the property owners post a sum to defray costs pursuant to Ordinance No. 70.
- (4) A public hearing to consider remonstrances against the proposed project is hereby set to be held at the Wilsonville City Hall in Wilsonville, Oregon, commencing at or shortly after 7:30 o'clock P.M., on Monday, January 4, 1982, and the City Recorder is hereby directed to give notice of such improvement project and public hearing by posting at the City Hall and at two other places within the benefited area, and by mailing of such notice to the owners of the property to be assessed for the costs of such improvements as required by Section 4 of Ordinance No. 70.
- (5) That the City of Wilsonville is in the process of adopting Wilsonville Code, 1981 which incorporates Ordinance No. 70. In the event the code is enacted prior to this resolution the code sections corresponding to the

sections of Ordinance No. 70 referred to in this resolution shall be deemed to supersede and be incorporated herein.
