## **RESOLUTION NO. 1362**

A RESOLUTION REVISING PARKS AND RECREATION CAPITAL IMPROVEMENT SYSTEMS DEVELOPMENT CHARGES WHICH WERE PREVIOUSLY ESTABLISHED BY RESOLUTION NO. 1145, AS AMENDED BY RESOLUTIONS NO. 1198 AND 1278 TO INCLUDE ANNUAL CHANGES OF THE CONSTRUCTION COST INDEX IN THE PACIFIC NORTHWEST AND NOW REVISED IN ACCORDANCE WITH RESOLUTION NO. 1358, WHICH AUTHORIZED SETTLEMENT OF A LAWSUIT, WHICH IN PART INVOLVED THE PARKS AND RECREATION CAPITAL IMPROVEMENT SYSTEMS DEVELOPMENT CHARGES.

WHEREAS, Resolution No. 1145 imposed parks and recreation capital improvement systems development charges; and

WHEREAS, Resolution No. 1198 approved a 1.3% increase in the supplemental street systems development charges based on a change in the Pacific Northwest Construction Cost Index; and

WHEREAS, Resolution No. 1278 approved a further increase of 1.9% based on an increase in the Pacific Northwest Construction Cost Index; and

WHEREAS, the city has reached a negotiated settlement in the lawsuit entitled Matrix Development Corporation versus The City of Wilsonville, Clackamas County Case Number 9501241 which dealt with the city's enactment of a supplemental street systems development charges; and

WHEREAS, by Resolution No. 1358 Council authorized the city manager to enter into a settlement of said lawsuit; and

WHEREAS, the settlement agreement involves a reduction in parks and recreation capital improvement systems development charges.

NOW, THEREFORE BE IT RESOLVED BY THE CITY OF WILSONVILLE, OREGON THAT:

- 1. The City Council adopts above recitals as findings and incorporates them by reference in support of this resolution.
- 2. The parks and recreation capital improvement systems development charges previously approved as Resolutions No. 1145, 1198, and 1278, recited above, shall be amended as stated in the attached table entitled Settlement SDCs.
