A RESOLUTION OF THE URBAN RENEWAL AGENCY OF THE CITY OF WILSONVILLE AMENDING RESOLUTION NO. 32 EXHIBIT 21, AND RESOLUTION NO. 40 EXHIBIT 2, PERTAINING TO THE WILSONVILLE ROAD PHASE 1 PROJECT.

WHEREAS, Resolution No. 32, adopted by the Urban Renewal Agency Board October 7, 1996, is entitled "A Resolution of the Urban Renewal Agency of the City of Wilsonville making findings and determinations authorizing and identifying minor changes to the Year 2000 Urban Renewal Plan and authorizing the acquisition of property and property interests to carry out the Urban Renewal Plan and to carry out a portion of Urban Renewal Plan Project 601.A.7, Wilsonville Road Phase 1"; and

WHEREAS, Resolution No. 40, adopted by the Urban Renewal Agency of the City of Wilsonville December 15, 1997, is entitled "A Resolution of the Urban Renewal Agency of the City of Wilsonville amending Resolution No. 32, pertaining to the Wilsonville Road Phase 1 project, adding exhibits 20 and 21"; and

WHEREAS, Exhibit 2 of Resolution No. 40 identifies and adds Exhibit 21 to Resolution No. 32 which identifies by legal description and map the right-of-way necessary and required for the public purpose of providing the Wilsonville Road Phase 1 improvements; and

WHEREAS, after further analysis it was deemed appropriate to revise Exhibit 2 of Resolution No. 40 which, in turn, revises Exhibit 21 of Resolution No. 32's legal description and map; and

WHEREAS, staff recommends amending Exhibit 2 of Resolution No. 40 and Exhibit 21 of Resolution No. 32 to correctly reflect the right-of-way required for the Wilsonville Road Phase 1 project.

NOW, THEREFORE, THE CITY OF WILSONVILLE URBAN RENEWAL AGENCY RESOLVES AS FOLLOWS:

1. The right-of-way legal description and map identified as Exhibit 1, attached hereto, is hereby adopted and shall amend Exhibit 2 of Resolution No. 40 which, in turn, amends Exhibit 21 of Resolution No. 32 by replacing the right-of-way legal description and map otherwise identified in Exhibit 2 and Exhibit 21.


