The purpose of this document is to provide a set of Operating Guidelines the will help to provide consistency in the P&R Advisory Board operations as Board members (and P&R Staff) change over time. These guidelines were developed by the Board, in consultation with the P&R Director and Staff (they are not approved/mandated by the City Council and can be updated as needed by the incumbent P&R Board to operate effectively).

#### BOARDS AND COMMISSIONS

#### 2.300 Parks and Recreation Advisory Board.

(1) A Parks and Recreation Advisory Board is hereby created. The Parks and Recreation Advisory Board shall consist of seven members. At least five members of the Parks and Recreation Advisory Board shall be residents of the City. Two members may reside outside of the city limits but must reside within the boundaries of the West Linn-Wilsonville, Canby, Sherwood, or North Marion school districts. Members shall be appointed by the Mayor with the consent of the City Council and may be removed by the Mayor with the consent of the Council. Of the members first appointed, four members shall be appointed for a two-year term and five members shall be appointed for a four-year term. Subsequent appointments shall be for a term of four years. No member shall hold appointment for more then two full consecutive terms, but any person may be appointed again to the Commission after an interval of one year. Amended by Ord #397 – 5/4/92

- (2) At its first meeting in each calendar year, the Board shall elect a Chairperson and Vice Chairperson. The Chairperson shall preside at all meetings and the vice Chairperson shall preside over the meetings in the event that the Chairperson is absent. Unless otherwise specified, Robert's Rules of Order shall govern the meetings. Board members shall serve without pay but may be reimbursed for any expenses incurred in the discharge of their duties, with the approved city policies and with prior approval of the Parks and Recreation director.
- (3) Four members shall constitute a quorum. *Amended by Ord.* #480 3.20/97.
- (4) Parks and Recreation Advisory Board members shall make every effort to attend all meetings. In the event that a member is absent from three meetings in any calendar year without either a pre-arranged excuse or an emergency, the Parks and Recreation Board may recommend removal of said member. Removal must be approved by the Council.
- (5) The board shall hold at least four meetings per year to conduct its business. All meetings of the Board shall be open to the public. *Amended by Ord. #346 3/6/89.*

#### 2.301 Purpose.

The purpose of the Parks and Recreation Advisory Board shall be as follows: to act as a channel of communication for the general public and the municipal administration. To take initiative in planning of present and future parks and recreation needs to support the people of Wilsonville. To advise the City Council on various policy matters which have been referred to them in regard to the provision of park and recreation services to the total community.

#### WILSONVILLE CODE

#### 2.302 Parks and Recreation Advisory Board Duties and Responsibilities.

- (1) Give due attention and study to recreation and park service as they affect the welfare of the people of Wilsonville.
- (2) Interpret the recreation and park services of the department to the community.
- (3) Interpret community recreation and park services of the department to the community.
- (4) Take initiative in planning for future recreation and park areas and facilities, as well as considering means of bringing present areas and facilities up to an acceptable standard.
- (5) Serve as a sounding board for the department administrator and staff to test their pans and ideas.
- (6) Recommend policy.
- (7) Enable civic and service organizations to accomplish results through cooperation.
- (8) Encourage individuals and citizen groups to give funds, property, and manpower for the development and operation of the recreation and park facilities.
- (9) Generally enlist community interest in recreation and parks.

#### 2.303 Advisory Functions.

The actions of the Parks and Recreation Advisory Board shall be advisory only and shall not constitute policy of the City and shall not be binding upon the City Council or upon the City. The City Council may adopt all or part of any recommendation of the Board, with or without changes as city policy.

# Roles & Responsibilities

The roles and responsibilities of the Parks and Recreation Advisory Board are to take the initiative in planning for the present and future park and recreational needs of the residents of Wilsonville and to act as a channel of communication between the general public and city government. The board also advises the City Council on any referred policy matters that pertain to parks and recreational services.

Members of the Parks and Recreation Advisory Board recommend policy and serve as a sounding board for the department administrator and staff. They are also responsible for determining how to bring the city's present recreation, park areas, and facilities up to an acceptable standard and maintain them at that level.

The board consists of up to seven members. At least five of the board members must live within Wilsonville city limits. Term length is four years, with no member holding office for more than two consecutive terms.

# Working Relationships - Greg McKenzie

During the summer of 2017, Greg McKenzie facilitated a series of meetings between the P&R Board, P&R Director and P&R senior staff. The goal of the meetings was to help develop good working relationships between the Board members and PR Director/Staff. There were two primary outputs from those meetings:

- 1) Direction to develop a set of Operating Guidelines for the Board
  - a. See the P&R Advisory Board Operating Guidelines.
- 2) Suggestions from the Board Members and PR Director/Staff on what would be helpful in supporting good working relations and in helping the parties be successful. Provided below is a summary of those suggestions.

Listed below are some items to keep in mind to help support strong, healthy dialogue between Board Members, P&R Staff and the Citizens of Wilsonville.

# Intra P&R Board Relationships

- Board members must take accountability to:
  - o Be familiar with the P&R Master Plans and other documents that are relevant to providing advise to the P&R Department.
  - o Read all meeting materials prior to the Board meeting.
- Value divergent opinions; Agree to disagree agreeably; Hold each other accountable
- Work collaboratively and respectfully with P&R Staff, Board members and the public
- View issues through other people's points of view/experience
- Understand the role of a P&R Board member; Perform duties with transparency
- Speak with one voice as the entire P&R Board after decisions
- Establish effective systems and processes for P&R Board operations

## Working Relationship with Parks & Recreation Department

The P&R Board needs from staff to be successful:

- 1. Communication and overview of the P&R Department's major goals and objectives, projects and programs
- 2. Overview of proposed major P&R projects/programs (i.e., new construction / renovations / changes) far enough in advance of implementation that the Board will be able to provide input before it is too late to efficiently make changes
- 3. A clear understanding of the decision-making process for Parks and Recreation projects
- 4. Timely reports about the progress of ongoing major Department projects

- 5. Timely presentations from staff about matters subject to P&R Board duties
- 6. Orientation for new P&R Board members about functions of the Department; Where key information (e.g., Master Plans) are located on the P&R website; City Codes that govern the P&R Board; Annual Budget and Five Year Capital Improvement Program; Etc.
- 7. Clarity from Mayor, City Manager and Parks Director about vision and direction for parks and services in Wilsonville
- 8. Clear understanding of the role of P&R Board in the delivery of parks, programs and services for Wilsonville
- 9. Assistance and instruction about effective ways for the P&R Board to communicate with the public about Department projects, programs and services
- 10. Process for taking public testimony about projects subject to the P&R Board jurisdiction
- 11. Criteria for approval of Opportunity Grants and Tourism Grants

Items 6, 9, 10, and 11 and maybe some others still need to be placed in Calendar.

# The P&R Department needs from the Board to be successful:

- Timely ideas and suggestions for programs and services
- Visibility in the Wilsonville community at Department events
- Provide sounding board regarding the implementation of Department programs and services
- Understanding from all P&R Board members about the role of the P&R Board and its relationship with Department staff
- Review and approval of Opportunity Grants
- Review projects submitted to Design Review Board with suggestions and recommendations
