Directors Report

Recreation and Aquatic Center

The Task Force for the Recreation and Aquatic Center voted to recommend that the Council proceed with the project on September 23rd. The Council will act on that recommendation in December. In the meantime, staff is proceeding with the site selection process and reviewing potential operational models. Potential sites will be judged based on criteria specific to the project. The criteria to be used will include site size, development costs, potential for building expansion, accessibility, environmental impacts, impacts on economic development and tourism, and if any partnership opportunities exists. Each site will be ranked based on the criteria selected to allow the City to identify which alternative to pursue.

Memorial Park Master Plan

Walker-Macy, a Portland area landscape architecture and planning firm, has been selected to manage the Memorial Park master planning process. The kick-off meeting for the consultant and staff was held on October 3rd. The project schedule projects a twenty two week process. The goal of the process is to balance passive and active recreational opportunities, seek low cost/high return improvements, identify how we can make the Willamette River more accessible, identify potential revenue producing activities and maintain the high quality recreational experiences for the community. The process will engage the entire community for input as well as rely on the Wilsonville Park and Recreation Board for direction.

Boone's Ferry Park Master Plan

We will soon be seeking proposals from local architectural firms to conduct a master planning process for Boone's Ferry Park. This process will address the needs of our other park with river frontage and recommend ways we can enhance the recreational experiences for park users.

Murase Playground Equipment Replacement

The Murase Plaza play structure will be replaced this fall. The current structure is a maintenance and safety concern. The slide does not meet the ASTM safety guidelines, which regulates safety guidelines for all playgrounds. The new structure will significantly increase the play value and play opportunities for all ages of kids. A considerable piece of the new playground will be totally accessible to children with physical limitations. We anticipate the project will completed in early spring. Once the contracts are executed, we will be able to share the new structures design and a schedule for demolition and reconstruction.

Parks and Recreation Board - Parks Report

Completed in September:

- Successful completion of Farmer's Market preparation and clean-up
- Cleaned out and itemized storage cage at the Maintenance Barn
- Cleaned out and organized Maintenance Barn
- Cleaned out and addressed issues with restroom storage areas
- Repaired damaged benches at Memorial Park
- Removed cement posts from upper picnic table site in Memorial Park to reduce vagary
- Installed no swimming/fishing signage at transient dock on Willamette River
- Repaired horseshoe pit following damage from River Shelter renter
- Painted fence at Daydream trail
- Continued pruning to increase irrigation efficiency and for improved safety
- Removed invasive and toxic species (Spurge Laurel) at Water Treatment Plant
- Pruned and removed understory vegetation at the Dog Park
- Removed broken skateboards from roof at lift station in Memorial Park
- Replaced lights at basketball, tennis, and pickleball courts
- Pressure washed dock and ramp
- Continued emphasis on safety training with seasonal new hires and full time staff
- Sprayed and removed holly & ivy after goats were in Memorial Park
