I. Call to Order

II. Public Input

No public input at this meeting.

III. ACHIEVE Award

Patty Brescia, M.A., Senior Programs Manager, reported on the ACHIEVE grant of \$50,000 awarded to Wilsonville from The National Recreation and Parks Association and the Centers for Disease Control. ACHIEVE stands for Action Communities for Health, Innovation and Environmental Change. The City of Wilsonville is one of 4 selected communities in 4 states that will develop and implement local activities focused on preventing chronic disease through raising public awareness about the effects of tobacco use, poor nutrition and physical inactivity.

Patty reported that she and Dr. David Duemling D.C., P.C., C.C.P.W. will be the ACHIEVE coaches for Wilsonville and will work on improving availability and accessibility of healthy lifestyle choices in the Wilsonville community.

IV. Tourism/Match Grant Application Review

Eric Bohard explained the process for the review. Agency representatives will be given 5 minutes to present their activity. Eric turned the meeting over to Parker Johnstone to begin the process.

Parker called for a representative from the Rotary organization. There was no representative from that group.

The next group, Celebration Days (Fun in the Park), was represented by Becky Nichols and Dawn Wilbur. They reported the project is in its 12th year and is a completely free event, designed to be a wholesome community coming together to amuse, entertain, educate and delight. They reported annual attendance has grown from approximately 4,000 to approximately 10,000. Their request is \$8,000.

The next group, Kiwanis Kids Fun Run, was represented by Gary Wappes, Chair of the event. He reported that 7 years ago, 50 youngsters ran the first year of the event. In 2011, 550 runners participated ranging in ages from prekindergarten through 8th grade. The event remains free to all participants. The event this year will be held at Wilsonville High School. He reported on the many community groups and businesses that support the Fun Run. Their request is \$4,000.

The next group, Wilsonville Festival of Arts, was represented by Theonie Gilmore, Executive Director of Wilsonville Arts and Culture Council. She reported this will be the 13th annual event and is free to all who attend. She explained that new this year will be a Film Fest on June 3. Again, artists will showcase and sell their art. Student, professional and community groups will offer full programming on stage. Their request is \$5,000.

The next group, Wilsonville-Boones Ferry Historical Society, was represented by Mick Scott, Project Chair. His organization is requesting funds for to produce and install two historical markers; one fronting the "Old Church" and the other at the site of one of Wilsonville's first farm homes built in the 1860's. He reported that more than 30 volunteers contributed over 200 hours to projects sponsored by the Society. Their request is \$1,925.

After hearing each of the representatives, the board discussed each one and addressed questions to each group. It was moved and seconded to grant full funding to each organization with a small additional amount.

Final awards are listed below.

Wilsonville Rotary – Concerts in the Park -\$6,000.00 Celebration Days – \$8,018.75 Kiwanis Kids Fun Run – \$4,018.75 Festival of Arts – \$5,018.75 Wilsonville Historical Society - \$1,943.75

The Board complimented each group and thanked them for their continued work to provide quality programs to the citizens of Wilsonville. The board also encouraged the applicants to be aware of the matching requirement and to be aware of the limits of "In-Kind" donations.

V. Staff Reports

Steve Hurst, City Council representative e-mailed his report as he was out of town. Each of the Board Members had a copy of his report and a copy is included in these minutes.

Peggy Watters reported the Spring program book has a reduced size in consideration of cost savings but includes all activities, classes and special events.

She explained Ordinance 701 that was passed by the City Council in regards to large special events being held in the city. All reservation applications have been updated to reflect the new ordinance and are ready for the reservation season.

The community garden reservations will begin March 22. Because of the heavy demand for plots, only one plot will be allowed per family.

Peggy remarked that his would be her last meeting with the Parks Board before her retirement and she thanked the Board for their support and guidance for the issues of parks and recreation throughout the city.

The Board thanked Peggy for her support and presented her with a token of their appreciation and wished her well in her retirement.

IV. Adjournment

There being no further business, the meeting adjourned at 8:05 p.m.
